## Fellowship Village Health Center Outdoor Visitation

Based on CDC, NJDOH and State guidelines starting June 21 Fellowship is welcoming family members and friends to visit their loved one(s) residing in the Health Center (Assisted, Memory Care, and Skilled) by adhering to the following guidelines:

- Visitation is restricted if the visitor currently has or had in the last 24 hours symptoms of **COVID-19**, for example, fever, cough, fatigue, congestion or runny nose, shortness of breath or difficulty breathing, sore throat, chills, repeated shaking with chills, muscle pain or body aches, headache, new loss of taste or smell OR G.I. symptoms (diarrhea, nausea, or vomiting). In addition, all visitors must complete and pass our screening process before visiting.
- Visitors must email [lifenrichment@fellowshipsl.org](mailto:lifenrichment@fellowshipsl.org) to request a visit in order to maintain proper social distancing. Please indicate name of resident, preferred day, time and who will be visiting (refer to limitations below). Visitors will receive an email within 24 hours by one of our life enrichment team members. Both the visitors and the resident will also need to sign an informed consent form prior to visitation.
  - Masks must be worn at all times (visitors & residents), no exceptions
  - Visiting hours are Monday to Thursday between 10:30 AM to 12:00 PM and 2:00 PM to 4:00 PM, weather permitting
  - Up to two visitors at a time (no pets)
  - Check-in at receptionist for screening, temperature check and sanitize hands
  - The receptionist will notify the resident that visitor(s) have arrived
  - Visitation must take place outdoors at least six feet away from the resident. No entrance to the households or physical contact is permitted.
  - Resident will be accompanied by a member of our life enrichment team at all times
  - Visitors will have designated seating
  - No food or drinks are permitted
  - Please plan accordingly; restrooms will not be available to visitors at this time
  - Visitation is limited to 15 minutes
- Visitor may bring items for their loved one but must leave the package at the reception desk for delivery
- Fellowship Village reserves the right to limit or cancel visitation or change the policy.
- If any visitor violates the above policy, they may put the lives of our residents at risk. Their loved one(s) may need to be isolated for up to 14 days or visitation restricted.
