



## **Independent Living Visitation – Revised 2/4/22**

### **Indoor Visiting Protocol – For Fully Vaccinated Residents and Visitors:**

- Indoor visiting may occur if both resident and visitors are fully vaccinated. Fully vaccinated is deemed complete 2 weeks after primary series vaccination is administered and if eligible, 2 weeks after latest available booster dose.
- On arrival visitor must enter through the Main Entrance and show vaccination card or picture of card to Receptionist for first visit. Receptionist will provide visitor with vaccination confirmation card. This card must be presented during check-in with Receptionist for subsequent visits.
- Visitor must be screened with temperature check and sign consent form (provided by Receptionist). Screening must be passed to proceed with the visit.
- Eating and drinking are not permitted within the common areas except when dining at indoor dining venues.
- Visitor and resident must wear mask at all times in common areas and while walking to resident's suite. Visitor may independently proceed to resident's suite.
- Masks may be removed in resident's suite only.
- Visitor must wear a mask if a care partner or other FSL personnel are within 6 feet inside the resident's suite.
- Practice frequent hand washing or use hand sanitizer when soap and water are unavailable.
- **After 5p, visitors must enter at the Health Center Entrance only.** The Receptionist will check for proof of COVID-19 vaccination, screen for COVID-19 with temperature check and obtain the consent. Screening must be passed to proceed with the visit.

**Outdoor Visitation Protocol – For Visitors and Residents Not Up to date with their Fully Vaccinated status:**

- Visitors who are not fully vaccinated or plan to see a resident not fully vaccinated may visit by appointment at Wilson's Tapas Bar Lounge on the heated porch or patio (weather permitting).
- Book appointment with the front desk reception at (908) 580-3800.
- Visitation is limited to once weekly for **30 minutes** based on availability.
- Up to **2 visitors** are permitted and must be at an age to tolerate wearing a mask. Visiting time may not be split to arrange for more visitors.
- Visitor should arrive **no earlier than 10 minutes** before the appointment time.
- Visitor must be screened with temperature check and sign consent form. (Provided by Receptionist). Screening must be passed to proceed with the visit.
- Visitor must sanitize hands and will be directed to the porch or patio of Wilson's Tapas Bar Lounge.
- **A well-fitting mask must be worn at all times.**
- Eating and drinking are not permitted indoors or on the porch/patio.
- Physical distancing of at least 6 feet from others is required.
- Visitor's pets are not allowed indoors or outside at Wilson's Tapas Bar Lounge.
